Announcement of Prequalification of Public Private Partnership ("PPP") Project for the Infrastructure Development of Singkawang Airport

The Committee for the Procurement of Implementing Business Entity of the Public Private Partnership for the New Airport in Singkawang City West Kalimantan Province ("**Project**"), established by the Director General of Civil Aviation, Ministry of Transportation acting as the Government Contracting Agency ("**GCA**"), invites national and international business entities to participate in the prequalification process for the procurement of the Implementing Business Entity ("**IBE**") for the Project. The procurement of the IBE will be conducted in accordance with the Presidential Regulation Number 38 of 2015 on Public Private Partnership for Infrastructure Provision. The Project aims to meet the public's need for air transportation services and is one of the national projects in line with the Ministry of Transportation's Strategic Plan.

The estimated capital expenditure for the Project is IDR 841.464.000.000,- (eight hundred forty-one billion four hundred sixty-four million Indonesian Rupiah), with an investment return mechanism through user charge/tariff. The Project will be executed under the Design-Build-Finance-Operation-Maintenance-Transfer (D-B-F-O-M-T) scheme, where the IBE will conduct both airport and airport-related service activities. This Project has been proposed to receive government guarantee through PT Penjaminan Infrastruktur Indonesia (Persero).

The Project will be implemented over 32 (thirty-two) years. In general, there are two phases of the Project development, consisting of:

a. Phase 1 Airport Facilities Development

Includes expansions such as runway extension, apron expansion, as well as the rearrangement or beautification of the existing passenger terminal and cargo terminal; and

b. Phase 2 Airport Facilities Development

Includes further apron expansion, passenger terminal development, as well as cargo terminal development.

The IBE is also required to operate the existing airport facilities established by the GCA.

The registration and retrieval of the prequalification document must be conducted by an authorized representative, who cannot represent more than one business entity/consortium, in accordance with the following conditions:

Procedure

Requirements

- a. A statement of interest signed by the president director or other authorized official;
- b. Proof that the registrant is the President Director or another official party authorized to represent the business entity or consortium;
- c. A power of attorney granted to the registrant by the President Director or another authorized party (in the event that the registration and document collection are conducted by a proxy);
- A copy of the establishment deed and any amendments to the articles of association reflecting the current composition of the board of directors of the business entity or the lead entity in the consortium (if the participant is a consortium);
- e. A copy of the consortium agreement (if the participant is a consortium); and
- f. A copy of the registrant's original identity document (resident identity card/KTP, driver's license, or passport).
